WELCOME TO ANDREW DALE RACING

On behalf of Andrew and his team at Andrew Dale Racing, we wish to extend a warm welcome to our stable and thank you for giving us the opportunity to care and manage the welfare and racing career of your thoroughbred.

At ADR, we invoice all owners monthly in arrears so you will receive your monthly account by no later than five (5) business days into the following month. These accounts are due for payment within seven (7) days of receipt.

Although it is not possible to indicate in advance the exact monthly cost of training your horse given variables such as whether your horse is in full work, spelling and / or racing, this Fees Notice sets out the common fees and charges incurred but of course does not cover all the expenses you will be charged.

While some fees and charges are calculated at a daily rate (i.e. training fee etc), others are calculated per treatment (i.e. veterinary, farrier, chiropractor etc) or per trip (i.e. transportation). Also, as each horse matures and progresses at different rates, the training costs will vary from one horse to the next depending on the point of their career preparation.

Notes

- All veterinary related charges (i.e. scope, drenches, ulcer-treatment, blood tests etc) vary from month to month
 for each horse and cannot be estimate in advance. The monthly veterinary charges will be included in your
 monthly training invoice.
- For an emergency veterinary treatment, prior approval will be sought where possible from the managing owner where an individual treatment is likely to exceed \$2,000.00 (including GST) in cost.

RACE ENTRY, NOMINATION, ACCEPTANCE, NON-ACCEPTANCE AND SCRATCHING FEES

- Race entry fees are not included in this Fees Notice they will be additional and depend on the race. The Proprietor should inform the managing owner of these as soon as practicable once known.
- All race nomination, acceptance, non-acceptance and scratching fees are set at by Principal Race Authorities (PRA) and/ or Race Clubs, and are passed on to the owner/s at cost. They should be checked with each relevant PRA or race club.

INTEREST ON OVERDUE TRAINING FEES AND/OR TRAINING DISBURSEMENTS

The Proprietor (Trainer) reserves the right to charge interest at a rate of 1% on any overdue training fees and/or Proprietor disbursements as permitted under the TOR Rules and a default fee of \$50.00 each time a payment of an account is overdue.



PROPRIETOR'S (TRAINER'S) ADDITIONAL REMUNERATION AND GRATUITIES

- 1. The Proprietor reserves the right to charge a stable bonus / commission not exceeding 5% of the net first prize money of any Group races won by the horse.
- 2. If the Horse, being an Entire, is sold or retired to stud, the Proprietor is entitled to an additional fee and/ or gratuity being an amount equal to 10% (plus GST) of the sale price of the horse and an additional one (1) transferable lifetime service right which will entitle the holder of such right to nominate a mare to be provided with a stud service by the Horse during each stud season that the Horse is used to provide stud services commercially, free of any service fee.
- 3. If the Horse, being other than an Entire to which paragraph 1 applies, is sold while being trained by the Proprietor, or within 3 months after ceasing to be trained by the Proprietor, an additional fee being an amount equal to 10% (plus GST) of the sale price (excluding GST).
- 4. If the Proprietor is involved in the purchase of the Horse, the Proprietor will be entitled to charge a fee of \$4,000 plus GST [total \$4,400] for services provided in relation to that process.

Notes:

- (1) The entitlements of the Proprietor to the additional remuneration and gratuities set out in paragraph 1:
 - (a) will be conditional upon the Horse winning a Group 1, Group 2 or Group 3 race while being trained by the Proprietor, or within 3 months after ceasing to be trained by the Proprietor; but
 - (b) will not be conditional upon the Proprietor being the Proprietor of the Horse at the time of it being sold or retired to stud.

The entitlements of the Proprietor to the additional remuneration set out in paragraphs 1 and 2 will also apply to the sale of an interest or share in the Horse.

IMPORTANT NOTE

If the managing owner does not object to this Fees Notice within 14 days of it being provided, the basis for charging set out is deemed to have been accepted. Further, all training and on costs apply retrospective to the 1st day of the month irrespective of date of ownership entry unless stated otherwise by the Trainer.
