

### FEES NOTICE AS AT 01/08/2021

This Fees Notice is intended to provide an Owner with an estimate only of fees and expenses. It is not a fixed price quotation.

Fees and charges are invoiced monthly in arrears. It is not possible to indicate in advance the exact total of monthly fees and charges, all treatments and trips, and the service provider. While some fees and charges are at a daily rate (e.g. training fee etc.), others are per treatment (e.g. chiropractor, dentist, farrier, veterinary etc.), and transportation per trip. Treatments will vary depending upon the horse's individual needs and not all possible treatments are itemized below. Also, horses vary in the rate at which they mature and progress while on agistment and throughout each preparation.

- Race entry fees are not included in this Fees Notice they will be additional and depend on the race.
- All race nomination, acceptance, non-acceptance and scratching fees are set by Principal Racing Clubs and are passed on to the Owner at cost.
- Interstate or overseas travel: should the Horse race interstate or overseas, charges reflecting a proportion of the additional associated expenses will apply.

# WHETHER INTEREST MAY BE CHARGED BY THE TRAINER ON OVERDUE TRAINING FEES AND/OR DISBURSEMENTS

The Trainer reserves the right to charge interest on any overdue Training Fees and/or Training Disbursements as permitted under the TOR Rules. If charged, it will be charged at the rate of 2%.

#### NON-PAYMENT OF THE TRAINER'S INVOICE AND ITS CONSEQUENCES

If the Trainer's invoice is issued in accordance with the TOR Rules and is not fully paid by the end of the month it is issued, then unless a Dispute Notice is lodged by the owner by the end of that month, the Trainer may file an Enforcement Action Application with Racing Australia seeking the following consequences:

- Not process any Stable Return seeking to transfer the horse to another trainer (if the owner owns at least 50% of the horse).
- Not register any transfer of the owner's share of the horse.
- Freeze payment of the owner's prizemoney and direct it to the Trainer.
